O. FOREWORD

- **0.1** This Indian Standard (First Revision) was adopted by the Indian Standards Institution on 26 September 1983, after the draft finalized by the Wood and Wood Products Containers Sectional Committee had been approved by the Marine, Cargo Movement and Packaging Division Council.
- **0.2** The current indigenous practices for packing tobacoo in bulk for export include packing it in a plywood case taking all necessary precautions that it withstands the hazards encountered in transportation. Such cases are required to be so constructed that they are amenable for easy opening, with the cake of tobacco left intact inside the case, for 'netting' purposes.
- **0.3** Two types of packing, namely, wooden cases and jute gunny or hessian bales are recommended in IS: 4698-1968*. This standard covers the requirements for packing in plywood cases.
- 0.4 This standard was first published in 1976. It has been revised to bring it in line with current trade practices. In the revised version, the moisture content of battens has been reduced from 18 to 15 percent. In the packing clause, provision has been made to use any suitable liner instead of only high density polyethylene. The clause for strapping of the box has also been suitably modified in accordance with the prevailing practices.
- 0.5 For the purpose of deciding whether a particular requirement of this standard is complied with, the final value, observed or calculated, expressing the result of a test or analysis, shall be rounded of in accordance with IS: 2-1960†. The number of significant places retained in the rounded off value should be the same as that of the specified value in this standard.

1. SCOPE

1.1 This standard prescribes the requirements for plywood cases for packing tobacco for export.

2. TERMINOLOGY

- 2.0 For the purpose of this standard, the following definition in addition to those given in IS: 707-1976*, and IS: 6703-1972† shall apply.
- 2.1 Objectionable Knots A live knot in a batten shall be considered objectionable if its diameter along the major axis exceeds one-third of the width of the batten; provided such knots do not reach the edge of the batten and are not more than one per 30 cm length of the batten or are situated within 25 mm from a place through which a nail will be driven.

3. DIMENSIONS

3.1 The dimensions of a typical case are as follows (see Fig. 1 and 2), or shall be as agreed to between the purchaser and supplier:

4. MATERIALS

4.1 Plywood — Plywood used for the fabrication of the case shall conform to the requirements of Type BC, WWR Grade of IS: 303-1975. The minimum thickness of the plywood shall be 6 mm.

4.2 Battens


- 4.2.1 Battens shall be manufactured from any of the timber species given under Group I, II or III of Appendix A of IS: 6662-1980§.
- 4.2.2 The battens shall be well seasoned to moisture content not exceeding 15 percent of its oven-dry mass when determined according to Appendix A of IS: 8358-1977||. They shall be reasonably straight grained, free from insect attack, centre heart (pitch), any kind of decay, objectionable knots, splits, warping and any other defect which is likely to reduce the strength of the battens.



- 4.3 Nails Countersunk head nails not less than 2.00 mm in shank diameter and conforming to IS: 723-1972* shall be used for fastening the plywood panels to the battens. The length of the nails shall be not less than 30 mm.
- 4.4 Wire Unless otherwise specified, soft round aluminium wire conforming to IS: 739-1977† shall be used for the fabrication of the packing cases. The diameter of the aluminium wire shall be not less than 3 mm.

5. CONSTRUCTION

5.1 Components

- 5.1.1 Top and Bottom Shooks The top and bottom shooks shall be made from 5-ply panels 1200×750 mm fixed with two battens of $737.5 \times 25 \times 25$ mm mitred on both ends as shown in Fig. 2.
- 5.1.2 Side Shooks Two side shooks shall be made from 5-ply panels $1\ 200 \times 737.5$ mm fixed with two $737.5 \times 25 \times 25$ mm battens mitred on both ends as shown in Fig. 2.
- **5.1.3** End Shooks End shooks shall be made from 5-ply panels 737.5×737.5 mm fixed with four battens comprising two battens of $687.5 \times 25 \times 25$ mm and rest two battens of $637.5 \times 25 \times 25$ mm as shown in Fig. 2.
- 5.2 Each batten shall be fixed with 14 to 16 nails as recommended in 4.3 to the plywood panels as shown in Fig. 1.
- 5.3 Make 6 mm dia grooves on all battens of the end shooks as shown in Fig. 2.
- 5.3.1 Drill 6 mm grooves and holes through the battens, panels on the side, bottom and top shooks as shown in Fig. 2.
- 5.4 Assembly Assemble the case with bottom, two side and two end shooks with the help of 12 pieces of aluminium wire each of suitable length as shown in Fig. 1.

6. PACKING OF TOBACCO

6.1 After assembling the case as in 5.4, a suitable liner, as agreed to between the purchaser and the seller shall be placed against all the interior walls of the packing case. Spread the tobacco in layers one upon the other in the case lined with suitable liner. Press the strips firmly from one to the other end of the case by using a thick wooden plank. A net mass of approximately 200 kg of tobacco may be packed in the typical case of the dimensions mentioned in 3.1 by an alternate process of filling and pressing with wooden plank.

Note — For a detailed procedure for packing, see 2.2 of IS: 4698-1968*.

7. CLOSING THE BOX

7.1 After filling the tobacco, fold the liner. The box shall be closed with the top shook as prepared in 5.1.1. The case shall be sealed with the 4 aluminium wires of suitable length as shown in Fig. 1.

7.1.1 The plywood case shall be further wound by three or four gerrard or aluminium wires. The wire shall be suitably secured.

8. MARKING

- 8.1 The plywood case shall be marked at least on two opposite sides with indelible ink with the following particulars:
 - a) Name or trade-mark of the manufacturer of tobacco;
 - b) Port of destination;
 - c) Customer's grade;
 - d) Serial number of the package;
 - e) Gross mass, tare and net mass of the package; and
 - f) Any other information required by the buyer and by the law in force of the concerned countries.
- 8.1.1 The case may also be marked with any handling instructions in accordance with IS: 1260 (Part 2)-1979*.
 - 8.1.2 The case may also be marked with the ISI Certification Mark.

Note — The use of the ISI Certification Mark is governed by the provisions of the Indian Standards Institution (Certification Marks) Act and the Rules and Regulations made thereunder. The ISI Mark on products covered by an Indian Standard conveys the assurance that they have been produced to comply with the requirements of that standard under a well-defined system of inspection, testing and quality control which is devised and supervised by ISI and operated by the producer. ISI marked products are also continuously checked by ISI for conformity to that standard as a further safeguard. Details of conditions under which a licence for the use of the ISI Certification Mark may be granted to manufacturers or processors, may be obtained from the Indian Standards Institution.
